I, the undersigned, do hereby promise on my word of honor, and swear true Faith, Allegiance and Fealty to the Supreme Council of Sovereign Grand Inspector-General of the Thirty-third and last degree of the Ancient Accepted Scottish Rite of Freemasonry for the Northern Masonic Jurisdiction of the United States of America, sitting at its Grand East in the City of Lexington, Massachusetts, and will support and abide by its Constitutions, Statutes, Orders and Degrees.

That I will hold allegiance to the said Supreme Council and be loyal thereto, as the Supreme Authority of the Rite so long as I may continue to reside within its Jurisdiction; will hold illegal and spurious every other body that may be established within its Jurisdiction, claiming to be a Supreme Council; and every other body of said Rite within the same Jurisdiction that does not hold its powers mediately or immediately from the Supreme Council, and will hold no communication whatever in Scottish Rite Masonry with any member of the same nor allow him to visit any body of the Rite of which I may be a member; and I will dispense justice to my brethren according to the laws of equity and honor.

And should I violate this, my solemn Vow and Pledge, I consent to be expelled from Scottish Rite Masonry, and all rights therin and in any body of the Rite, and to be denounced to every body of the Ancient Accepted Scottish Rite in the world as a traitor and forsworn.
